

## Proposed Plan Change 2 – Public Notice of Availability of Summary of Submissions and Invitation to Lodge Further Submissions

The Summary of Submissions and Decisions Requested on Proposed Plan Change 2 to the One Plan is now available, along with copies of the submissions. Plan Change 2 is focused on the One Plan provisions that manage nutrient loss from existing intensive farming land uses in target Water Management Sub-zones. Further submissions are sought on the submissions that have been made.

The following people may make a further submission no later than 10 working days after the day on which this public notice is given:

- Any person representing a relevant aspect of the public interest; or
- Any person that has an interest in the proposal greater than the interest that the general public has; or
- The local authority itself (Manawatū-Whanganui Regional Council).

The last day for making further submissions is **3 December 2019 at 5:00 pm**.

A further submission may only express support or opposition to a matter raised in an original submission (made under clauses 6 or 6A of Schedule 1, RMA). It must not raise new points of submission.

Further submissions must be lodged using the prescribed form (Form 6) of the Resource Management (Forms, Fees and Procedure) Regulations 2003, which can be completed online at Horizons' website (<http://www.horizons.govt.nz/publications-feedback/current-consultation/further-submissions-on-pc2-form>) or downloaded from the legislation website at <http://www.legislation.govt.nz/regulation/public/2003/0153/latest/DLM195863.html>. You can access these electronically at your local library or Horizons Service Centre during opening hours.

You must also send a copy to the original submitter no later than 5 working days after lodging your further submission with the Manawatū-Whanganui Regional Council (required by Clause 8A, Schedule 1 of the RMA).



Following the close of further submissions, a report will be prepared on Proposed Plan Change 2 and a hearing date will be set and notified to all submitters and further submitters who wish to be heard.
