Empowering communities	<ul style="list-style-type: none"> • Council delivered a Climate Change Action Workshop with the Horowhenua Youth Empowerment Project (yEP) after successfully applying for funding from the Climate Impact Fund. The workshop was designed to engage and empower rangatahi with tools for climate action. • In December, Horowhenua was awarded a sixth Green Flag Award for Jubilee Park in Levin, along with the reconfirmation of our five other Green Flags. The Green Flag Award is a prestigious international award. This is due to the passion and dedication of our Parks & Property Team in collaboration with green spaces contractors and community groups. • Council's social media lead visited Shannon School (Te Kura o Hanana) to see their zero-waste practices. Led by Principal Nick Julian, it encompassed minimal food packaging, efficient food waste management, self-sustainable gardening, active recycling initiatives, community involvement, and the recent addition of chickens to their sustainable ecosystem. We shared their exemplary efforts 	<ul style="list-style-type: none"> • Awaiting direction from the 2024-2044 Long Term Plan. • Horowhenua is working in partnership with the Wellington Regional Leadership Committee across projects that ensure future development planning is taken with a strategic approach. A key aspect of this planning is the Regional Emissions Reduction Strategy that outlines an approach to transition to a zero-carbon environment, working together to make the most impact. The strategy is currently with graphic designers and will be taken to the WRLC for endorsement in the next 6 months. • As we consult on the Waste Management and Minimisation Plan, we have created a social media campaign focused on environmental sustainability to engage our community and promote behaviour change.

Working with nature	<ul style="list-style-type: none"> • Promotion of sustainable water supply over summer months through sharing education on social media, schools and tips on how to conserve. • The Waitārere Beach Surf Life Saving Club opened 2 December 2023. This facility has been designed to be resilient to future environmental impacts, and enables safe use and access to Waitārere Beach. • Throughout October/November the Parks & Property Team have undertaken a number of community planting days at various sites on Horowhenua's coast. This is to plant spinifex and pingao, foredune plants that appreciably build resilience on our coastal townships by stabilising the interface between land and sea. These recent plantings at the tail end of spring are the culmination of this year's programme of planting, which includes approximately 12,000 spinifex plants and 500 pingao plants. This programme is great news for our biodiversity, providing habitat for wildlife with the support of ecologically minded community who embraced helping on this work. • Council has engaged with a nature-based solutions expert to understand potential outcomes for Horowhenua, that will be incorporated into the draft Climate Action Plan. 	<ul style="list-style-type: none"> • Awaiting direction from the 2024-2044 Long Term Plan.
