Dear Carina,

We are now in a position to provide the points of clarification sought by the Panel, having initiated discussions with Rangitāne o Tamaki nui-ā-Rua ("Rangitāne") and Kahungunu ki Tamaki nui-ā-rua ("Kahungunu"). We apologise for the delay in getting back to you. Our responses are as follows:

With the Pahiatua application how long exactly do they seek to finalise the design of the wetland?

TDC seeks a period of two months from Tuesday 6 June 2017 (that being the date of TDC's discussions with Rangitāne and Kahungunu) to finalise the design of the wetland. This takes into account a meeting that has been scheduled for early July between Roger MacGibbon and representatives from both iwi groups to discuss wetland design.

With Eketahuna the timeline does not specify when the new consent applications relating to the wetland will be lodged. Can they please specify when this will be.

TDC proposes lodging the new consent applications by Friday, 2 February 2018. While we acknowledge this is a slightly longer timeframe than the six month timeframe envisaged by the Panel during the hearing, we consider this is appropriate given that a six month timeframe would take us into the busy Christmas period. Extending it to the first week of February will therefore ensure all discussions and engagement with iwi, the community and all relevant stakeholders are undertaken with due care, rather than being rushed in the lead-up to Christmas holidays. This timeline also takes into account the time required by Rangitāne and Kahungunu to prepare the CVAs.

I hope this clarifies matters for the Panel. Please let me know if there are any other questions.
