# 6. Work Programme Update

A Natural Character Index study has been commissioned from Dr Russell Death (River Research) for the Ōroua and Pohangina Rivers. The Lower Manawatū River has been completed as part of a separate project, and this report is available on the project webpage.

Mapping of hard geological features is underway, and the historic channel lines have been digitized.

The design channels lines from the 2002 Scheme Review have also been digitized. Logan Brown demonstrated that river management lines have been in place for some time, but in some places the river has changed considerably since the lines were drawn. Going forward, the group will need to discuss how these lines should be redrawn.

Discussion was had around the potential impacts that gravel extraction can have in degrading conditions, such as undermining of key infrastructure and incising river channels.

# 7. Communication and Relationships

Letters and info-sheets have been posted to landowners whose properties are close to the rivers. The Horizons project team are happy to meet people individually or in groups to discuss the project, either during the week or in the evenings/weekends if preferred.

No feedback was received from the press release in the Farmers Weekly.

# 8. Mātauranga Māori

Rangitāne o Manawatū will be providing their own report on values and the inclusion of Mātauranga Māori in the project. Ngāti Apa and Ngāti Hauiti will provide a joint report. Rangitāne o Tamaki nui-ā-Rua will discuss their approach with Rangitāne o Manawatū. Yet to hear from Ngāti Kauwhata.

A new webpage will be published on the project page titled "Mātauranga Māori" and will include links to the 'Iwi and Hapū Management Plans' webpage on the Horizons' website.
