Acknowledgement

1. The parties below acknowledge that this is a true and correct record of the meeting.

Conferencing notes Whanganui Prison Stormwater discharge consent.

Present: Regional Council: Natasha Adsett (NA), Logan Brown (LB), Ben Woolston (note taker).
Applicant: Peter Hall (PH), Ewen Robertson - Ara Poutama Department of Corrections (ER) and tangata whenua representatives Chris Shenton (CS) and Jill Sheehy (JS).

- The points of agreement and disagreement are attached in the table and marked in **yellow**. Due to time constraints the parties did not discuss all conditions. Changes made and circulated by PH prior to the meeting are in **Grey**. Natasha circulated additional comments to the parties following the meeting which are highlighted in **green**. Peter Hall responded on behalf of Ara Poutama Department of Corrections to the further changes made by Natasha after the conditions meeting and these changes are highlighted on the attached in **blue**. Chris Shenton has also added 2 sub clauses in condition 12 in **purple**. Comments from Jill Sheehy are in **Pink**. A column has been inserted on the far right to show outstanding points of disagreement between parties.
1. Ngāti Tumango /Ngāti Tūpoho Hapu of Putiki Wharanui Marae, Te Rūnanga o Tūpoho, Ngati Rangihakaturia Hapu of Whangaehu Marae and Te Rūnanga o Ngā Wairiki Ngāti Apa request the opportunity to discuss the best practical option for stormwater discharge to the Wiritoa Outlet as stated by the Commissioner and agreed by Mr Quinn, appears to be within the scope of the application and the items mentioned below.
 - a. request the cultural impact assessment be integrated into the BPO. There was confusion around the consent regarding the number of options available for discharge.
 - b. request the stormwater discharge option to be a hybrid/co-design option developed with Iwi, Te Ara Poutama, Matauranga Maori and western civil engineers.
 - c. request to implement a biodiversity audit.
 - d. request all the impact assessment recommendations be addressed.
 2. PH does not agree that the Panel stated, nor that Mr Quinn agreed, that the discharge to the Lake Wiritoa outlet was within the scope of this application. That would require another application and consent.
 3. NA noted the parties did not get an opportunity to discuss which conditions would be included should the panel be of a mind to grant the consent for a short term (ie. 3- 5 years). NA is of the opinion the following conditions would need to be included 1, 2 4, 5, 11, 13, 14, 15, 16, 22, 23, 24, 27, 28, 29. In addition it may be appropriate to include a modified condition 12 and additional conditions for a timeline to explore and report on the lodging of a renewal consent.

4. PH does not consider a short-term consent is appropriate or warranted and were such a consent term to be imposed then only the conditions of the existing consent should be imposed.
5. Ngāti Tumango /Ngāti Tūpoho Hapu of Putiki Wharanui Marae, Te Rūnanga o Tūpoho, Ngati Rangiwahakaturia Hapu of Whangaehu Marae and Te Rūnanga o Ngā Wairiki Ngāti Apa support a short-term consent (ie. 3- 5 years) to enable maatauranga hybrid co-design including rock / vegetated swale to Wiritoa outlet and the receiving environment to be fully constructed and planted. Agree with NA for modified and additional conditions.
6. Ngāti Tumango /Ngāti Tūpoho Hapu of Putiki Wharanui Marae, Te Rūnanga o Tūpoho, Ngati Rangiwahakaturia Hapu of Whangaehu Marae and Te Rūnanga o Ngā Wairiki Ngāti Apa oppose in its entirety the prison stormwater application to discharge into the connecting stream of Lakes Wiritoa and Pauri.
