1 Welcome

Rachel welcomed everyone to the meeting. Sam opened with karakia.

2 Apologies

Apologies were received from Di Rump (proxy vote given to Dean), Jonathan Proctor (proxy vote given to Dean), Quentin Parr, Bryan Smith, Clinton Hemana and Daniel Haigh.

3 Conflicts of Interest

No new COI were registered.

4 Consenting update

Jason provided a verbal update on the consent and application.

The final day for the Fast Track consent application to be submitted prior to the Christmas shut down is the 22nd of December 2023. The final drafts of the technical assessments and associated effect reports are on track for submission prior to Christmas. If the Fast Track application is not submitted by the 8th January 2024, a standard resource consent process will need to be followed which would take longer and add additional costs to the process.

Originally a soft lodgment of the application with the EPA was to occur however, there is no longer time available to do this. This isn't required for the process it was proposed to make sure that the application contained all the information that it needed to.

Lodgment of the resource consent application will be prior to the next Governance Group meeting.

Action: The Governance Group are to be informed when the consent is lodged.

5 Water recirculation option

The project team proposed to include the recirculation of water from the Arawhata Stream into the wetland as a provision in the application in case it is needed for the wetland in the future. There was a discussion around this option.

The inclusion of a recirculation option allows for the potential for greater nitrogen removal and more hydrological control over the wetland for better functioning during drier periods.

Resolution:

The Governance Group endorse the resource consent application being lodged with the recirculation option included as a part of the proposal. Acknowledging that the recirculation component is optional and can be used to enhance treatment and/or hydrological performance.

6 Walkway alignment

There has recently been an article in the paper interviewing Geoff Kane proposing a walkway through the Arawhata farm. The wetland design has provision for a walkway in phase three of the design however, is not included in the consent application for Phases one or two. Geoff has presented to HDC Councillors around a walkway, starting with the northern parcel of land that isn't part of the wetland design.

7 Cropping on the farm

There have been concerns raised by the community around the perception of a farm purchased for a wetland being used for cropping. Some of this feedback has been that the land was used being used for horticulture, the use of fertilizer on the farm etc. The lease for the land is for dry stock farming and cropping (cut and carry operations such as maize and grass silage). The current use of the land for cropping are within the terms of the lease. This current lease is a reduction in the leaching rates compared to the dairy operation that existed prior to 1st June 2023.

Archaeological surveys via Daniel Parker and MTA team members were completed for the land that had been ploughed for cropping. Nothing of concern was noted.

8 Other business

There was a discussion around the use of the northern block of land that was purchased as a part of the wetland project. This included the use of the existing track as a part of the track network, the use of the area for potential stormwater treatment options etc. All of these being wider options that the land could be used for. A future Governance Group meeting will need to consider the use of the northern block of the land purchased for the wetland complex.

The next Governance Group meeting will be in late January 2024.
